- Complete a Personal Statement (details within application)
- Plan to enroll in, beginning in the fall of 2019, undergraduate classes at an accredited two or four-year college or university, or accredited trade or vocational school

Employees of Credit Union ONE of Michigan and their immediate family are ineligible to receive a scholarship.

- Explain any special circumstances that you would like the committee to consider (optional)
- Submit a copy of your resume (optional)
- Submit academic transcripts (required)
- Add your signature before you submit the application

Type your Personal Statement on 8.5" x 11" paper, double spaced, in size 12 Times New Roman font, with your name and address at the top. Statements of excessive length will be disqualified.
