

Credit Union ONE Southwest Branch Mural Contest Submissions

Eligibility and Entry:

- Open to all residents of the state of Michigan aged 18 or older
- Participants do not need to be a member of Credit Union ONE
- No Credit Union ONE or Icon Mortgage Employees may enter contest
- No entry fee

Design and Content Guidelines

- The theme of the mural should reflect the spirit and community of Southwest Detroit
- Designs must be free of copyrighted imagery, trademarks or brand logos
- Submissions must not contain profane, obscene or defamatory imagery
- Submissions must be able to be replicated or scaled to a 6ft x 4ft canvas
- Winner to be present at Mural Unveiling at the Grand Opening on October 15, 2026

Submissions:

- All entries must be received by midnight eastern time on September 14, 2026
- Entries must be submitted by emailing contest@cuone.org in an attachment form. Attachment cannot exceed 20 megabytes in size
- A brief artist statement explaining the concept and how it ties to the theme
- Submit a high-resolution digital file of a completed artwork that can be scaled to a 6 ft x 4 ft mural format or submit a detailed design concept (such as a sketch or thumbnail) that clearly demonstrates the final vision and can be accurately translated to a 6 ft x 4 ft mural and completed by the unveiling date
- If the artist chooses to create the piece on canvas directly, the final product must be submitted in-person to the Ferndale branch at 400 E 9 Mile Rd, Ferndale, MI 48220 by the September 14, 2026
- Winner can either submit a digital image for printing that can be replicated or submit the piece in-person at the Ferndale branch (address listed above). Winner will be selected by or on September 18, 2026
- Final Winning Artwork must be ready by October 9, 2026
- The winner must be present for the Grand Opening at the Southwest branch on October 15, 2026
- Artwork created primarily or entirely through A.I. generation, or entries that fail to accurately disclose or represent the use of A.I. or other media, may be disqualified

Selections:

- Winner will be chosen by a committee selected by Credit Union ONE

Prize

- \$1,000 to the Grand Prize Winner
- The winner will also receive a \$100 stipend for the art materials

Submission Terms and Agreement

When submitting artwork, you must agree to the following terms and conditions:

I certify that I am at least 18 years of age, that I have read, understand, and agree to the official rules, and that the submission, including text and illustrations, and any ancillary material were made and submitted by me (Submitter, and were not copied from another work, photograph, illustration, or website, nor made by another person). I represent that this submission does not infringe on any copyright or third-party intellectual property rights, nor does it contain any material that is defamatory, vulgar, abusive, or otherwise inappropriate. I understand that the submission, including text and illustrations, and any ancillary material will become the property of Credit Union ONE. I give permission to Credit Union ONE to use, reproduce, prepare derivative works, publish, distribute copies to the public, perform publicly, and display publicly the submission, including text and illustrations, and any ancillary material, including but not limited to, Submitter's photographs and/or videos containing the Submitter for all purposes deemed appropriate by Credit Union ONE. Credit Union ONE may distribute the submission, including text and illustrations, and any ancillary material through a variety of media, including but not limited to print, television, websites, or any other means. Credit Union ONE may also permit a third party to exercise Credit Union ONE's rights, including but not limited to the right to display or distribute the submission, including text and illustrations, and any ancillary material, in a manner Credit Union ONE deems appropriate. Winner is responsible for any taxes.
